



Volunteer Release Waiver Liability Form

I agree that Alliance of Chicanos, Hispanic and Latin Americans (ACHLA) its staff (including volunteers), Board of Directors, and affiliated agencies shall not be held liable for any claims, demands, actions, or causes of action, whatsoever, for any injury caused to me as a result of my involvement in ACHLA related to Pata de Perro- Community Bike Club.

1. **Waiver and Release:** I, the Volunteer, release and forever discharge and hold harmless ACHLA and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to ACHLA. I understand and acknowledge that this Release discharges ACHLA from any liability or claim that I may have against ACHLA with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to ACHLA or occurring while I am providing volunteer services.
2. **Insurance:** Further I understand that ACHLA does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of ACHLA beyond what may be offered freely by ACHLA in the event of injury or medical expenses incurred by me.
3. **Medical Treatment:** I hereby Release and forever discharge ACHLA from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with ACHLA. I also authorize ACHLA staff, to secure any emergency treatment that may be required in the event of injury.
4. **Assumption of Risk:** I understand that the services I provide to ACHLA may include activities that may be hazardous to me. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and ACHLA from all liability.

5. **Photographic Release:** I grant and convey to ACHLA all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by ACHLA in connection with my providing volunteer services to ACHLA.

6. **Nature of Volunteer Work:** Evaluate existing donated bicycles in the possession of ACHLA, dividing them into repairable and salvage groups. Salvage bikes will be used for parts to repair bikes in the repairable group.

7. **Other:** As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Minnesota and that this Release shall be governed by and interpreted in accordance with the laws of the State of Minnesota. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.

Acknowledgment and Agreement: Volunteer Release Waiver Liability Form

I understand the Community Bike Workshop procedure: Upon completion of repairs to any donated bikes these bikes will be granted to individuals and/or organizations. Recipients of the granted bikes will sign the Patron Release Waiver Liability Form. This agreement includes the waived liability of the volunteer bike mechanics with the text: "I hereby agree to hold Alliance of Chicanos, Hispanic and Latin Americans (ACHLA) its board, volunteers, agents and contractors harmless and I waive any right to make claims or bring lawsuits against any of the afore mentioned parties for any injuries or damages related to any alleged negligence." This signed waiver releases the liability of the volunteer bike mechanics for workmanship.
